Authority:

CERC (Regulation of Power Supply Regulations)-2010 dated 28.09.2010. Regulation 10 of the above CERC regulation for concurrent regulation read along with the corrigendum No. L-1/42/2010-CERC issued on 5th September 2011.

Scheme of Regulation :

1. Back ground :

- a. Power Grid Corporation of India Ltd (POWERGRID) had proposed 600 MW of Power Supply Regulation w.e.f. 00:00 hrs. of 29.04.2018 from KSK Mahanadi Power Co. Ltd., a generating station located at Chhattisgarh, in Western Region.
- b. POWERGRID has submitted through an affidavit to indemnify, defend and save the SLDC, RLDCs (WRLDC & SRLDC in the instant case) harmless from any and all damages, losses, claims and actions, demands, suits, recoveries, cost and expenses, court costs, attorney fees, and all other obligations arising out of or resulting from the regulation of power in terms of the regulations to its procurers listed at 1(a) above. This indemnification is in line with section 5 of the CERC (Regulation of Power Supply) Regulations and paragraph 13.9 of the Statement of Reasons for these regulations.

2. Regulation:

This revised regulation will be effected from **00:00 hrs. of the 29.04.2018**. The regulation shall continue as stated at Table-1 above under the field “**Period of Regulation**” or up to an earlier date if default is rectified which would be communicated by the regulating entity to WRLDC in line with the CERC Regulations. The regulation will be implemented by reducing the scheduled generation of KSK Mahanadi and drawal schedule of corresponding beneficiary of Southern Region as per Table -1. SLDCs of Andhra Pradesh and Tamil Nadu will have to regulate drawal schedule for the intra-state regulated entities and WRLDC would regulate injection schedule of KSK Mahanadi Power Co. Ltd.

Scheme:

- i) As per the existing procedure followed at WRLDC, KSK Mahanadi Power Co. Ltd. is punching the agreed schedule between KSK Mahanadi Power Co. Ltd. & its firm beneficiaries viz. APDISCOMs and TANGEDCO in the web based energy scheduling (WBES) Portal maximum up to the LTA/PPA quantum as mentioned in Table-1 above.
- ii) During Regulation of Power Supply period WRLDC shall restrict the scheduled injection as per the quantum given in Table-1 above.
- iii) SRLDC may also restrict the drawal schedule to APDISCOMs and TANGEDCO up to the quantum as mentioned in Table-1 above.
- iv) SLDCs of the regulated state (i.e. Andhra Pradesh & Tamil Nadu) would work out the DISCOM wise entitlement from the figures communicated by WRLDC / SRLDC and forward the same to their DISCOMS.
- v) Those DISCOMs while communicating their requisition from KSK MAHANADI POWER CO. LTD. (given in Table-1) to SLDCs of Andhra Pradesh & Tamil Nadu, would give the restricted quantum as per the Table-1.
- vi) SLDCs of Andhra Pradesh & Tamil Nadu would aggregate the requisitions received from each DISCOM in the respective states. While doing so, the SLDCs would ensure that the requisition by their DISCOMs is reduced to the quantum as mentioned in Table-1 .

- vii) The SLDCs will ensure that the total requisition by the states from KSK MAHANADI POWER CO. LTD. is reduced by the regulated MW quantum as mentioned in Table – 1.
- viii) WRLDC / SRLDC shall incorporate the requisitions sent by the SLDCs of Andhra Pradesh & Tamil Nadu.
- ix) The corridor released due to Regulation of Power Supply (i.e. 600 MW on WR-SR) corridor shall be considered for STOA approvals on day ahead / contingency basis as per the extant regulations of Hon'ble CERC.

3. Grid Security Aspect:

WRLDC/SRLDC and SLDCs of Andhra Pradesh & Tamil Nadu, would closely monitor the system parameters during the period of power supply regulation and would take prompt action to maintain the grid parameters within safe limit. In case of overdrawal by the defaulting entities, the SLDC would take prompt action to curtail the overdrawal for safe operation of the grid. All the entities including regulating and regulated would take prompt action in respect of grid security and on receipt of any instruction from WRLDC, SRLDC, SLDCs of Andhra Pradesh & Tamil Nadu. WRLDC/SRLDC may defer this implementation plan for regulation of power supply in case of any grid security related issue in line with Regulation 11(2) of the CERC (Regulation of Power Supply), Regulation, 2010.

4. Power Supply to essential services:

SLDCs of Andhra Pradesh & Tamil Nadu will ensure that power supply to sensitive/important installations like defense, mines, medical, water-supply, aviation, railways, installations of national importance etc. are not affected on account of this regulation. Further SLDC of the affected entities (DISCOMs of Andhra Pradesh & Tamil Nadu) due to the above regulation on KSK MAHANADI POWER CO. LTD. shall ensure that there is no impact, if any, on international agreements and other sovereign obligations.

5. Deferment / Withdrawal of regulation:

Regulating Entity proposing to withdraw / postpone the regulation, shall inform at least **two days** prior to the proposed day of withdrawal or postponement of such regulation as per the regulation 9 of CERC regulations.
