## Scheme of Regulation :

### 1. Back ground :

- a. Presently, regulation of 42 MW on MSEDCL is ongoing as per earlier RPS notice of RGPPL dated 21.05.2019. RGPPL has proposed a increase in regulation of power supply from 42 MW to 68 MW from RGPPL vide notice dated 07.06.19. Accordingly this implementation plan shall be effective from 00:00 hrs of 11.06.2019.
- b. RGPPL has submitted through an affidavit to indemnify, defend and save the SLDC, RLDCs (WRLDC) harmless from any and all damages, losses, claims and actions, demands, suits, recoveries, cost and expenses, court costs, attorney fees, and all other obligations arising out of or resulting from the regulation of power in terms of the regulations to its procurers listed at 1(a) above. This indemnification is in line with section 5 of the CERC (Regulation of Power Supply) Regulations and paragraph 13.9 of the Statement of Reasons for these regulations.

### 2. Regulation:

This revised regulation of **68 MW** will be effected from **00:00 hrs. of 11.06.2019**. The regulation shall continue till the time as stated at Table-1, under the field "**Period of Regulation**" or up to an earlier date if default is rectified which would be communicated by the regulating entity to WRLDC in line with the CERC Regulations. The regulation will be implemented by reducing the power scheduled from RGPPL to Maharashtra. The concerned SLDCs (Maharashtra) will regulate drawal schedule for the respective intra-state entities.

#### Scheme:

- i) As per the existing procedure, RGPPL is punching the Declared capability and SLDC Maharashtra is punching the requisition maximum up to the entitlement quantum as mentioned in Table-1 above.
- ii) During regulation of power supply period, WRLDC shall restrict the scheduled injection as per the quantum given in Table-1 above.
- iii) SLDCs of the regulated entities (i.e. Maharashtra) would work out the DISCOM wise entitlement from the figures communicated by WRLDC and forward the same to their DISCOMS.
- iv) Those DISCOMs while communicating their requisition from RGPPL (given in Table-1) to Maharashtra SLDC would give the restricted quantum as per the Table-1.
- v) Maharashtra SLDC would aggregate the requisitions (in MW) received from each DISCOM. While doing so, the SLDC Maharashtra would ensure that the requisition is regulated with reference to the quantum as mentioned in Table-1.
- vi) WRLDC shall prepare the schedule accordingly.

### 3. Grid Security Aspect:

WRLDC and the SLDC Maharashtra would closely monitor the system parameters during the period of power supply regulation and would take prompt action to maintain the grid parameters within safe limit. In case of over-drawal by the defaulting entities, the SLDC would take prompt action to curtail the over-

drawal for safe operation of the grid. All the entities including regulating and regulated would take prompt action in respect of grid security and on receipt of any instruction from WRLDC & the SLDC Maharashtra. WRLDC may defer this implementation plan for regulation of power supply in case of any grid security related issue in line with Regulation 11(2) of the CERC (Regulation of Power Supply), Regulation, 2010.

**4. Power Supply to essential services:**

SLDC Maharashtra will ensure that power supply to sensitive/important installations like defense, mines, medical, water-supply, aviation, railways, installations of national importance etc. are not affected on account of this regulation. Further SLDC of the affected entities (DISCOMs of Maharashtra) due to the above regulation on MSEDCL shall ensure that there is no impact, if any, on international agreements and other sovereign obligations.

**5. Deferment / Withdrawal of regulation:**

Regulating Entity proposing to withdraw / postpone the regulation, shall inform at least **two days** prior to the proposed day of withdrawal or postponement of such regulation as per the regulation 9 of CERC regulations.
